Melanie Nowlin, Edgemont Drive, is opposed to the plantings on Edgemont Drive. Ms. Nowlin also spoke about the hedges, that mimic a fence around the perimeter of a property in Loch Arbour. She stated she is opposed to the height of the hedges. Ms. Nowlin also reminded all Village residents to leash their dogs.

Sam Shamie, Euclid Avenue, suggested that a mass email should be sent to all residents regarding leaving a porch light on to deter criminal activity. Mayor Fernicola advised the Clerk to send out a mass email. Mayor Fernicola stated The Village is looking into purchasing a sign that flashes the speed of the car, to deter speeding on Euclid Avenue, near Mr. Shamie's property.

Remo Maisto, Elberon Avenue, commented about the Ocean view from his home is obstructed.

WHEREAS, the Lease to operate the James V. Kiely Pavilion at the Village Beach has expired and must be rebid; and,

WHEREAS, the Lease was rebid and proposals were to be received on November 24, 2020, with no proposals being received on said date;

WHEREAS, the Board of Commissioners reviewed and hereby modified the bid specs as follows:

- The minimum bid for 2021 that will be considered by the Village is \$13,000.
- The minimum bid for 2022 that will be considered by the Village is no less than the 2021 rent plus 10%.
- The minimum bid for 2023 (option year) that will be considered by the Village is no less than 2022 rent plus 10%
- #10.g of the prior bid, the language regarding the reimbursement to the
 Village for the bathroom cleaning supplies is hereby omitted.
- #18 of the prior bid, the language regarding the reimbursement to the Village for refuse and recycling disposal is hereby omitted.

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Village of Loch Arbour that the proposed bid specifications and documents be approved as modified.
