AN ORDINANCE TO AMEND ORDINANCE NO. 296, ESTABLISHING THE MINIMUM REGULATIONS GOVERNING THE CONDITIONS AND MAINTENANCE OF ALL PROPERTY, BUILDINGS AND STRUCTURES, BY PROVIDING THE STANDARDS FOR SUPPLIED UTILITIES AND FACILITIES AND OTHER PHYSICAL THINGS AND CONDITIONS ESSENTIAL TO ENSURE THAT STRUCTURES ARE SAFE, SANTIARY AND FIT FOR OCCUPATION AND USE; AND THE CONDEMNATION OF BUILDINGS AND STRUCTURES UNFIT FOR HUMAN OCCUPANCY AND USE AND THE DEMOLITION OF SUCH STRUCTURES; KNOWN AS THE PROPERTY MAINTENANCE CODE AND REPEALING ORDINANCES NO. 229 AND 255 OF THE VILLAGE OF LOCH ARBOUR, MONMOUTH COUNTY, NEW JERSEY

BE IT ORDAINED by the Board of Commissioners of the Village of Loch Arbour, in the County of Monmouth and State of New Jersey, as follows:

Section 2. Additions, Insertions and Changes.

That the International Property Maintenance Code is amended and revised in the following respects:

B. Section 103.6 Fees: The fees for activities and services performed by the department in carrying out its responsibilities under this code shall be as indicated in the following schedule:

Certificate of Occupancy Inspection

a. Rental of Property \$100.00b. Sale of Property \$125.00

Smoke Detector Inspection \$ 35.00

Section 3. Date of Effect

This Ordinance shall take effect immediately upon its final passage and publication as required by law.

- A. **School Tax Issues** Mayor Fernicola reported both parties have submitted briefs regarding the Appeal. No court date has been set. Mayor Fernicola anticipates a Fall, 2018 court date.
