B. Ordinance 2018-437 - introduction

The Mayor read the Ordinance by Title:

ORDINANCE 2018-437

AN ORDINANCE TO AMEND ORDINANCE NO. 156 ENTITLED "AN ORDINANCE ESTABLISHING LAND USE DEVELOPMENT REGULATIONS AND RESTRICTIONS PURSUANT TO THE MINICIPAL LAND USE LAW (CHAPTER 291, P.L. 1975); ESTABLISHING A ZONING BOARD OF ADJUSTMENT AND PLANNING BOARD PURSUANT TO SAID LAW; AND REPEALING ALL PRIOR ORDINANCES RELATING TO ZONING AND PLANNING, AND PROVIDING PENALTIES FOR THE VIOLATION OF THE TERMS AND PROVISIONS THEREOF IN THE VILLAGE OF LOCH ARBOUR, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY" SO AS TO CONFORM WITH THE MASTER PLAN OF THE VILLAGE OF LOCH ARBOUR

BE IT ORDAINED by the Board of Commissioners of the Village of Loch Arbour, in the County of Monmouth and the State of New Jersey, that the Ordinance referred to in the title hereof is amended and supplemented as follows:

Section 1. Section 705 of Article 7, "C" Commercial, is hereby amended to read as follows:

A. Principal Permitted Use on Land and in Buildings

Office buildings and banks; churches or other places of worship; car wash; tavern; restaurant for sit-down dinners only and with no drive-in facilities; and retail businesses.

Section 2. All Ordinances or parts of Ordinances which are inconsistent herewith are repealed, but only to the extent of such inconsistency.

Section 3. This Ordinance shall take effect immediately upon its final passage and publication as required by law.

C. Ordinance 2018-438 - introduction

The Mayor read the Ordinance by Title:

ORDINANCE NO. 2018-438

AN ORDINANCE TO EXCEED THE CALENDAR YEAR 2018
MUNICIPAL BUDGET APPROPRIATION LIMITS AND
TO ESTABLISH A CAP BANK
(N.J.S.A. 40A:4-45.14)

BE IT ORDAINED by the Board of Commissioners of the Village of Loch Arbour as follows:

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A:4-45.1, et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and.

WHEREAS, the Board of Commissioners of the Village of Loch Arbour in the County of Monmouth finds it advisable and necessary to increase its CY 2018 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of its citizens; and,

WHEREAS, the Board of Commissioners hereby determines that a 3.5% increase in the budget for the said year, amounting to \$10,453.49 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Board of Commissioners hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Village of Loch Arbour, in the County of Monmouth, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2018 budget year, the final appropriations of the Village of Loch Arbour shall, in accordance with this ordinance and N.J.S.A. 40A:4-45.14, be increased by 3.5%, amounting to \$10,453.49 and that the CY 2018 municipal budget for the Village of Loch Arbour be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED that a certified copy of this ordinance, upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

WHEREAS, the Village of Loch Arbour 2018 Municipal Budget of \$1,228,911.17 which includes a local amount raised for Taxation at \$630,400.00 was introduced and approved on the 11^{th} day of April, 2018; and,

WHEREAS, pursuant to N.J.S.A. 40A:4-1, et seq., the Synopsis of the Budget will be published in *The Coaster* on April 19, 2018 and the Affidavit of Publication will be on file in the Village Clerk's office; and,

WHEREAS, a public hearing thereon is scheduled to be held on the 9th day of May, 2018.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Village of Loch Arbour that the budget hereinbefore set forth shall constitute an appropriation for the purposes stated of the sums therein set forth as appropriations, and authorization of the amount of \$1,228,911.17 for municipal purposes.

E.Resolution 2018-57: UPON MOTION, of Mayor Fernicola, seconded by Commissioner D' Angelo carried that the following Resolution be adopted:

WHEREAS, the Village of Loch Arbour is in need of a Chief Financial Officer, due to the resignation of Michael Mariniello, Jr., effective March 31, 2018;

WHEREAS, Jersey Professional Management (JPM) has submitted a proposal to provide, a temporary acting Chief Financial Officer dated December 18, 2017;

WHEREAS, Richard Wright, Jr., is a Certified Municipal Financial Officer (CMFO) and is duly qualified to serve as Village CFO;

WHEREAS, the Board of Commissioners of the Village of Loch Arbour wishes to have Richard Wright, Jr., serve as temporary acting Chief Financial Officer effective April 1, 2018 in accordance with a proposal by JPM dated December 18, 2017;

WHEREAS, adequate funds exist for this expenditure in the 2018 temporary operating budget of the Village of Loch Arbour;

WHEREAS, the Local Public Contracts Law <u>N.J.S.A.</u> 40A:11-1 et seq., permits the Resolution authorizing the award of this contract without competitive bidding but provides that the same must be advertised after passage as required by law.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Village of Loch Arbour, County of Monmouth, State of New Jersey, as follows:

- 1. The Board of Commissioners hereby authorizes and awards a contract to Jersey Professional Management for temporary acting Chief Financial Officer and Management Consultant Services in accordance with the proposal dated December 28, 2017.
- 2. The fees for these services will be at an houly rate of \$110.00 per hour for time worked as a temporary Acting Chief Financial Officer and Management Consultant based upon \$10.00 per hour payroll and \$100.00 per hour on voucher.
- 3. This resolution shall further authorize the appointment of Richard Wright, Jr., CMFO, as temporary acting Chief Financial Officer of the Village of Loch Arbour effective April 1, 2018, subject to cancellation of this agreement in accordance with the terms of JPM's proposal dated December 18, 2017.
- 4. This appointment is made without competitive bidding as this appointment involves a professional services contract and therefore exempt under N.J.S.A. 40A:11-5.
- 5. A copy of this resolution shall be published within ten (10) days of its passage as required by law.

BE IT FURTHER RESOLVED that a certified copy of this resolution shall be supplied to Jersey Professional Management, 23 North Avenue East, Cranford, New Jersey 07016 and Richard Wright, Jr.

WHEREAS, the Village provided payment for all services provided by Jersey Professional Management during the period of time listed above;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Village of Loch Arbour that the Mayor of the Board of Commissioners and Village Clerk of the Village of Loch Arbour be the same are hereby authorized to execute and deliver a Shared Services Agreement with the Loch Arbour Board of Education, which agreement is on file in the office of the Village Clerk at the Village of Loch Arbour Municipal Building, 550 Main Street, and available for public inspection during regular business hours.
