3. Approve the Audit and Recommendation for the 2021-2022 Audit

WHEREAS, the annual audit of the fiscal operations of the Loch Arbour Board of Education for the Fiscal year July 1, 2021 through June 30, 2022 has been conducted by the independent firm of Alvino and Schechter; and

WHEREAS, the Board of Education has reviewed the findings of the Report of the Audit and acknowledges that there was one finding for a recommendation for corrective action,

THEREFORE, the Loch Arbour Board of Education accepts the 2020-2021 Audit and approves the corrective action plan.

Recommendation #1:

Increase the Business Administrators Bond from 100K to 125K because of the increasing budget for 22-23 school year and moving forward.

Corrective Action:

Called our Insurance Broker to increase the Loch Arbour Bond to 125K for the Business Administrator so that we are covered for the limits for the budget and for futur budgets.

Method of Implementation:

Asked for the budget / insurance bond schedule so see the limits and coverage for the insurance so going forward if we need to adjust it we can do this accordingly.
