A. Ordinance 2021-471 – introduction

ORDINANCE NO. 2021-471

AN ORDINANCE BY VILLAGE OF LOCH ARBOUR IN THE COUNTY OF MONMOUTH, NEW JERSEY, PROHIBITING THE OPERATION OF ANY CLASS OF CANNABIS BUSINESSES WITHIN ITS GEOGRAPHICAL BOUNDARIES AND REPEALING VILLAGE ORDINANCE 2018-452

- **B. Resolution 2021-47:** Introduction of 2021 Municipal Budget (Budget Hearing to be held on May 5, 2021 at 6:30 p.m.)
