HOUSEHOLD REFUSE T	<ul style="list-style-type: none"> • WHEN: TUESDAY AND FRIDAY • WHERE: REAR YARD • Limited to 3 – 30 gallon containers per pick-up
APPLIANCES, WHITE GOODS, METAL R	<ul style="list-style-type: none"> • WHEN: BY APPOINTMENT (Borough of Deal, 732.531.1454) • WHERE: curbside • APPLIANCES CONTAINING FREON (refrigerators, air conditioners, dehumidifiers, water coolers) are subject to an additional charge of \$20 for freon removal, payable to the Borough of Deal. Payment must be made in advance.
BATTERIES, HOUSEHOLD *	<ul style="list-style-type: none"> • Regular alkaline batteries – dispose of with household trash • Rechargeable batteries – return to location of purchase for recycling
BRANCHES (SMALL) AND BRUSH R	<ul style="list-style-type: none"> • WHEN: THURSDAY • WHERE: curbside; NOT PILED IN THE GUTTERLINE • HOW: CONTAINERIZED • NOTE: Branches must be less than 4' long and 3" in diameter; DEBRIS LEFT AT THE CURB WILL NOT BE PICKED UP; CITATIONS WILL BE ISSUED FOR VIOLATIONS • CONTRACTOR-GENERATED MATERIAL MUST BE REMOVED BY CONTRACTOR
BULK TRASH Note: Check the date for bulk pick-ups. Material must be at the curb no later than 7:00 AM on the day of pick-up. T	<ul style="list-style-type: none"> • WHEN: January 23, March 6, May 8, July 10, September 11, November 13 • WHERE: curbside • WHAT: Furniture, lawn furniture, mattresses, rugs (tied, 4' lengths), clothes, chairs including beach chairs, cabinets, appliances (not containing CFC's) • HOW: Containers weighing less than 50 lbs. • CONTRACTOR-GENERATED MATERIAL MUST BE REMOVED BY CONTRACTOR
COMMINGLED: BOTTLES, CANS, PLASTIC CONTAINERS R	<ul style="list-style-type: none"> • WHEN: 1st and 3rd Wednesday • WHERE: curbside by 7:00 AM • WHAT: Aluminum cans, tin or bi-metal cans, glass bottles and jars, plastic containers for milk, juice, soda, detergent, bleach. • HOW: Rinsed and placed in a maximum 30 gallon container <p>DO NOT PLACE RECYCLABLES IN PLASTIC BAGS RECYCLABLES WILL NOT BE PICKED UP</p>
CONCRETE, BRICK *	<ul style="list-style-type: none"> • See Bulk Trash information • CONTRACTOR-GENERATED MATERIAL MUST BE REMOVED BY CONTRACTOR
CORRUGATED CARDBOARD R	<ul style="list-style-type: none"> • WHEN: 1ST and 3rd Wednesday • WHERE: curbside by 7:00 AM • HOW: "Broken down" (flattened) and tied into bundles weighing less than 50 lbs.
GRASS	<ul style="list-style-type: none"> • Banned from the landfill and will not be picked up. • Experts recommend leaving clippings on the lawn.
CHRISTMAS TREES R	<ul style="list-style-type: none"> • WHEN: January • WHERE: curbside only • HOW: FREE OF DECORATIONS, not bagged

HOUSEHOLD HAZARDOUS WASTE *	<ul style="list-style-type: none"> • WHEN: BY APPOINTMENT ONLY at (732) 683-8686 • WHERE: MONMOUTH COUNTY RECLAMATION CENTER, SHAFTO ROAD, TINTON FALLS • WHAT: Pesticides, herbicides, solvents, paint, pool chemicals, motor oil, antifreeze
LEAVES R	<ul style="list-style-type: none"> • WHEN: JANUARY 1 THROUGH SEPTEMBER 30 • WHERE: curbside only (containerized) • WHEN: OCTOBER 1 THROUGH DECEMBER 31 • WHERE: at the curb • HOW: CLEAN PILES OF LEAVES (<i>NO BRUSH</i> or other debris may be included)
MIXED PAPER R	<ul style="list-style-type: none"> • WHEN: 1st, 3rd and 5th Wednesday • WHERE: curbside by 7:00 AM • WHAT: Magazines, paperback books, computer paper, catalogs, writing paper, office paper, envelopes, fax paper, non-metallic wrapping paper, real estate books, NCR paper, sales flyers • HOW: May either be securely tied in bundles weighing less than 50 lbs. or placed in a covered 30 gallon container • NO CEREAL BOXES, PIZZA BOXES, PLASTIC COATED PAPER, PAPER NAPKINS OR TOWELS, BLUEPRINTS; dispose of these items with household trash
NEWSPAPER R	<ul style="list-style-type: none"> • WHEN: 1st, 3rd and 5th Wednesday • WHERE: curbside by 7:00 AM • WHAT: Newspaper and newsprint • HOW: Tied into bundles not more than 12" high weighing less than 50 lbs.
PAINT AND PAINT CANS T	<ul style="list-style-type: none"> • Open Cans (less than 1" in the can) • WHEN: Tuesday and Friday • WHAT: latex or oil based paints • WHERE: Rear Yard (place with household trash in containers for disposal) • HOW: Remove lid, <i>allowing the liquid to dry.</i> • Full Cans – latex or oil-based paint • WHEN: BY APPOINTMENT ONLY • WHERE: Monmouth County Reclamation Center (732) 683.8686 (Household Hazardous Waste by appointment)
PLANTS (HOUSE) T	<ul style="list-style-type: none"> • With household trash (does not include outdoor plants, shrubs or branch clippings – see BRUSH for proper disposal method) • DO NOT LEAVE AT THE CURB
TELEPHONE BOOKS R	<ul style="list-style-type: none"> • July • INCLUDE WITH MIXED PAPER
TIRES *	<ul style="list-style-type: none"> • by special pick-up only, Borough of Deal 732.531.1454 • \$2 each; \$5 each for tires on rims; payable in advance to the Borough of Deal
COMPUTERS & ELECTRONICS R	<ul style="list-style-type: none"> • WHEN: By appointment only • Monmouth County Reclamation Center, Gate A, Main Entrance or Long Branch Recycling Facility, 378 Atlantic Avenue (across from Pleasure Bay Park) (732) 571-6520 • WHAT: Computer cases, CPU's, keyboards, mice, monitors, scanners, printers, cables, laptops, peripherals, TV's (no larger than 42"), radios, telephones, cameras, VCR's, DVD players, stereo components
